Gifts of Real Estate

Consider a gift of real estate

Gifts of real estate can have significant impact on families in need of safe and affordable shelter while helping supporters like you avoid the hassle of selling property and realize valuable tax benefits.

Habitat understands how important real estate can be to a family and its history. One way to honor that significance is to use the property to create your legacy for future generations. Your gift of real estate to Habitat for Humanity empowers other families who are working to realize their dream of home ownership.

Consider these questions:

- Do you want to make a transformational gift that can change the lives of several families and help them live in decent housing?
- Do you own a property that has become difficult to manage or that your children will not want or need?
- Are you interested in avoiding capital gains tax on appreciated property?
- Are you eager to dispose of a property but wary of the process?
- Could you use an income tax deduction now but have your property go to Habitat later?

If you answer “yes” to any of the above questions, a gift of real estate to Habitat might be the best option for you.

Getting started

Many different types of property can qualify for a charitable gift of real estate to Habitat for Humanity. The most common are:

- Primary residences
- Farms and ranches
- Vacation homes
- Undeveloped land, including land with timber
- Commercial property

How it works

When you make a gift of real estate to support families in need of decent, affordable housing through Habitat, you'll also enjoy tax benefits, like current income tax deductions and reducing or avoiding capital gains tax. The most common ways to create this type of gift follow:

Donate the property outright: This option frees you from the costs and responsibilities of ownership. If you have owned the property for more than a year, you will enjoy an income tax deduction equal to the property's appraised value. You eliminate both recapture and capital gains taxes, as well as most other state taxes. The gift also reduces your future taxable estate.

Include Habitat in your will or trust: When you include a gift of real estate in your will or living trust, your estate may be eligible for a charitable tax deduction. This gift of real estate enables you to leave a larger gift than you may be able to during your lifetime. It also offers the flexibility to adjust your purpose if your philanthropic priorities change and grow. In some states you can even make this gift using a beneficiary designation on a deed.
